- I. **Positions Advertised:-**Registrar ; Chief Finance Officer ; Sr.Manager/Manager (Corporate Communications) ; Sr.Manager/Manager (Start Up Operations); Sr.Manager/Manager (Human Resource Development); Research Engineers, Senior Research Engineers, Team Leaders, Group Leaders and other Senior Positions in the Work Area of RAN & 5GRAN, ITU Common Alerting Protocol, Network Security, 4G/5G Core, Quantum Communications, Post Quantum Cryptography, Validation & Field Support, Artificial Intelligence
- II. **Tenure of Appointment :** All officers shall be first appointed on contract basis for a period for five years and will include a probationary period (normally 1 year). The contract will be renewed based on satisfactory performance review for further periods of five years at a time, till attaining the age of superannuation (present superannuation age being 60 years), as amended from time to time by the governing council) or the dissolution of the society. **a) Age Criteria (As on 01.01.2022)**

- GEN/EWS CATEGORY : Not exceeding 45 years
- OBC CATEGORY : Not exceeding 48 years
- SC/ST/PH CATEGORY : Not exceeding 50 years

**b) Marks Criteria(in High School, Intermediate and Graduation) :**

- 65 % or 6.5 CGPA (on 10 point scale) for GENERAL/EWS
  - 55% or 5.5 CGPA for SC/ST/OBC/PH
- Linear conversions will be done if any other scale is followed
